


New Vacancies for Boards and Commissions



ZONING & DESIGN REVIEW BOARD (ZDRB)

The Yountville Town Council is seeking one (1) community volunteer to serve on the Zoning and Design Review Board (ZDRB) to fill an unexpired term with the term of office commencing December 1, 2016 and expiring July 19, 2018. The purpose of the ZDRB is to review matters related to planning and development and make recommendations to the Town Council consistent with Yountville's Zoning and Design Ordinances, General Plan and administrative policies. The Town will be embarking on a General Plan Update in the near future. Other items for consideration include, but are not limited to, residential design, variances, commercial design, master development plans, use permits, sign permits, rezones, land use and design policies. Meetings are held on the second Tuesday of each month at 6:00 p.m. in Town Council Chambers located at 6550 Yount Street, Yountville. **Applications must be submitted on-line by November 3, 2016 at 5:00 p.m.**

NAPA COUNTY LOCAL FOOD ADVISORY COUNCIL – YOUNTVILLE REPRESENTATIVE

The Yountville Town Council is seeking one (1) individual to fill an unexpired term of office to represent the Town on the Napa County Local Food Advisory Council with the term of office to expire February 1, 2017. The Advisory Council's purpose is to collaborate on development and promotion of a sustainable local food system and help set priorities, plan and implement initiatives to improve the environmental, economic and social sustainability of food production in Napa County; including, but not limited to, creating greater local food security, increased agricultural diversity and more reliable markets for small-scale farmers. The CAC will provide feedback to the NVTA Board and staff on various transportation projects, on all modes of transportation, and other transit issues.
