

Town of Yountville Ordinance Number 21-500

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF YOUNTVILLE AMENDING TITLE 13 OF THE YOUNTVILLE MUNICIPAL CODE REGARDING ENFORCEMENT OF MANDATORY WATER CONSERVATION MEASURES

Whereas at The Town of Yountville Town Council Meeting held on the June 15 special meeting, the Town Council introduced and held, and waived, a first reading of this Ordinance.

Whereas a Second Reading and Adopt Ordinance Number 21-500 Amending Title 13 of the Yountville Municipal Code Regarding Enforcement of Mandatory Water Conservation Measures is required before the Second Reading shall be held before the Ordinance is allowed to take effect.

Now, therefore, the Town Council of the Town of Yountville does ordain as follows:

SECTION 1. CODE AMENDMENT: Subsection D. of Section 13.24.080 of Chapter 13.24 of Title 13 of the Yountville Municipal Code is hereby added to read as follows:

D. Any violation of this chapter, or any rule or regulation adopted by resolution of the Town Council under this chapter or Section 13.08.020, shall be a "code violation" under Chapter 8.05 in addition to any other lawful means of enforcement. If the Town enforces a violation of this chapter, or any rule or regulation adopted by resolution of the Town Council under this chapter or Section 13.08.020, as a "code violation" under Chapter 8.05, the procedures in Chapter 8.05 shall control over any conflicting procedures contained in this chapter.

SECTION 2. CEQA: The Town Council has considered all of the evidence in the record, including the staff report, the testimony received during the meeting on the matter held by the Town Council, and hereby determines that this Ordinance is exempt from review under the California Environmental Quality Act (CEQA). Pursuant to section 15061(b)(3) of the CEQA Guidelines, CEQA applies only to projects which have the potential for causing a significant effect on the environment. This Ordinance will not result in a significant foreseeable environmental impact.

SECTION 3. Severability: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The Town Council declares that it would have adopted this Ordinance, and each section, subsection, sentence, clause, phrase or portion thereof, irrespective of the fact that any one or more sections, subsections, phrases or portions might be declared invalid or unconstitutional.

SECTION 4. Effective Date: This Ordinance shall take effect 30 days after final adoption.

SECTION 5. Certification: The Town Clerk shall certify to the passage and adoption of this Ordinance and shall give notice of its adoption as required by law. Within 15 days from the date of passage of this ordinance, the Town Clerk shall post a copy of the ordinance in accordance

with California Government Code in at least three public places in the Town.
